Dear Public Service Director,

Right now, more than 437,000 children are in foster care in the United States, 125,000 of whom have been permanently removed from their family of origin because of abuse and neglect. Sadly, the number of children waiting to be adopted from foster care is on the rise — <u>a 23 percent increase</u> since 2012.

Our nation's child welfare system is being stretched far beyond its capacity as families are devastated by the opioid crisis and other issues. Unresolved through policy and evidence-based, innovative practices, this problem has far-reaching impacts. Last year, nearly 20,000 teens turned 18 or 21 and aged out of care without a permanent home. With nowhere to turn for support, many are at a higher risk of negative outcomes, such as homelessness, unemployment and early parenting, which can happen to a child who can't go home and simply say, "I need some help."

Created in 1992 by Wendy's[®] founder Dave Thomas, who was adopted, the Dave Thomas Foundation for Adoption is the only public nonprofit charity in the United States focused exclusively on foster care adoption.

Through our signature program, <u>Wendy's Wonderful Kids</u>[®], the Foundation provides funding to adoption agencies to hire recruiters who implement an evidence-based, child-focused recruitment model. The model is proven to be up to three times more effective at serving children who have been in foster care the longest, including teenagers, children with special needs and siblings.

With support from the Foundation's generous donors, the Foundation has helped find forever families for more than 9,000 children across the United States. But there is more work to be done to serve children still waiting to be adopted who need our help the most.

RADIO PSA SCRIPTS

"Before I Was Adopted — Teen Voices" (:60)

<u>GIRL 1 V/O:</u> Before I was adopted, I felt like nobody wanted me. I felt like my life was already over.

BOY 1 V/O: At a certain age they don't want you. You're troubled and stuff. Even if I wanted to be adopted who would adopt a 17-year-old?

GIRL 2 V/O: Inside I knew, like I'm not a troubled kid. I know what I'm in for, why I'm here.

BOY 2 V/O: My biggest fear was that I would age out and not know how to be sufficient on my own.

<u>GIRL 3 V/O:</u> I had nightmares every single day in my birth mom's house. It was just really scary for me living there.

BOY 3 V/O: I was scared. I was lost. And I felt hopeless.

GIRL 4 V/O: I felt like, don't I deserve to feel happy and loved?

BOY 4 V/O: I just wish I had gotten adopted sooner.

Dear Applicant:

This modifies our letter of the above date in which we stated that you would be treated as an organization that is not a private foundation until the expiration of your advance ruling period.

Your exempt status under section 501(a) of the Internal Revenue Code as an organization described in section 501(c)(3) is still in effect. Based on the information you submitted, we have determined that you are not a private foundation within the meaning of section 509(a) of the Code because you are an organization of the type described in section 509(a)(2).

Grantors and contributors may rely on this determination unless the Internal Revenue Service publishes notice to the contrary. Nowever, if you lose your section 509(a)(2) status, a grantor or contributor may not rely on this determination if he or she was in part responsible for, or was aware of, the act or failure to act, or the substantial or material change on the part of the organization that resulted in your loss of such status, or if he or she acquired knowledge that the Internal Revenue Service had given notice that you would no longer be classified as a section 509(a)(2) organization.

If we have indicated in the heading of this letter that an addendum applies, the addendum enclosed is an integral part of this letter.

Because this letter could help resolve any questions about your private foundation status, please keep it in your permanent records.
