Dear Public Service Director,

With the warm weather upon us, many people are looking forward to enjoying the summer months and spending time outdoors, especially after the difficult year we have all endured. As we begin to get back to our daily lives and activities, we must remain vigilant about protecting our health and safety – particularly in our home environments. Safeguarding our health from disease-carrying pests such as ticks, mosquitoes, cockroaches, rats and mice is paramount.

Ticks found in tall grass around the home can spread Lyme disease and other illnesses which can lead to chronic health issues. The Centers for Disease Control and Prevention (CDC) estimates that nearly half a million people across the country are diagnosed with Lyme disease each year. Allergens left behind by dust mites, roaches and rodents are a major driver of asthma attacks, especially in children. Mosquitoes spread West Nile virus and many other diseases. Additionally, they can breed in standing water around the home.

Awareness and education are critical for safeguarding our communities from pest-related health threats. Your station can help by airing the new public service announcement (PSA), titled "Abstract" (:30). This timely PSA helps educate audiences about the symptoms and harmful effects caused by pest-related health conditions. The PSA also includes an informational website, PestWorld.org, which offers further details and educational resources. While this PSA is very timely for the summer months, we ask that you please air this throughout the year as there is no end date for use.

The NPMA is a nonprofit organization committed to the protection of public health, food and property from the diseases and dangers posed by common household pests. The association conducts public education and awareness programs to promote increased vigilance around the home.

Unless specifically excepted, you are liable for taxes under the Federal Insurance Contributions Act (social security taxes) for each employee to whom you pay \$100 or more during a calendar year, And, unless excepted, you are also liable for tax under the Federal Unemployment Tax Act for each employee to whom you pay \$50 or more during a calendar quarter if, during the current or preceding calendar year, you had one or more employees at any time in each of 20 calendar weeks or you paid wages of \$1,500 or more in any calendar quarter. If you have any questions about excise, employment, or other Federal taxes, please address them to this office.

If your sources of support, or your purposes, character, or method of operation change, please let us know so we can consider the effect of the change on your exempt status. In the case of an amendment to your organizational document or bylaws, please send us a copy of the amended document or bylaws, Also, you should inform us of all changes in your name or address.

In the heading of this letter we have indicated whether you must file Form 990. Return of Organization Exempt From Income Tax. If Yes is indicated, you are required to file Form 990 only if your gross receipts each year are normally more than \$25,000. Nowever, if you receive a Form 990 package in the mail, please file the return even if you do not exceed the gross receipts test. If you are not required to file, simply attach the label provided, check the box in the heading to indicate that your annual gross receipts are normally \$25,000 or less, and sign the return.

If a return is required, it must be filed by the 15th day of the fifth
