Dear Public Service Director,

Right now in the United States, more than 400,000 children, through no fault of their own, are in foster care. For more than 100,000 of them, a judge has ruled that it's not safe to return to their family of origin. These children are simply waiting for someone to step forward to adopt them.

But every day, more than 50 youth age out of the system without a permanent family, leaving them at a higher risk of experiencing homelessness, unemployment and other negative outcomes.

Created in 1992 by Wendy's<sup>®</sup> founder Dave Thomas who was adopted, the Dave Thomas Foundation for Adoption is a national nonprofit public charity dedicated to dramatically increasing the number of adoptions of children waiting in North America's foster care systems.

The Foundation's generous donors empower our work to raise awareness about the urgent need for foster care adoption, advocate for adoption benefits in the workplace and support the continued expansion of our <u>Wendy's Wonderful Kids® program</u>. A rigorous, five-year national evaluation revealed that children referred to Wendy's Wonderful Kids are **up to 3x more likely to be adopted from foster care**.

The Foundation has helped find forever families for more than 12,000 children. But there is more work to be done to serve children still waiting to be adopted who need our help the most.



#### "If the Walls Could Talk" — Brianna's Story (:60)

**Brianna V/O:** Living with my mom was really bad because she did a lot of stuff that wasn't meant for kids to see.

**Brianna O/C:** I basically fended for me and my siblings, myself. Helping cook dinner, helping clean, taking care of my sister, making sure she was fed and everything.

Brianna V/O: My mom was caught doing drugs.

**Brianna O/C:** Everybody got involved and they said, "This is not where children are supposed to be. This is not how they're supposed to grow up." So, they removed me and my siblings and put us into foster care.

<u>Narrator V/O:</u> Brianna spent nine years in foster care waiting for a permanent, loving family. With help from the Dave Thomas Foundation for Adoption, Brianna's journey changed when she was adopted.

**Brianna V/O:** After I was adopted, I felt very safe. And I'm now a senior, and I'm planning on going to college for culinary arts.

Brianna O/C: I definitely see myself going in the right direction.

**<u>Narrator V/O:</u>** There are more than 100,000 children in foster care, like Brianna, who need a family now. You can help us find them the safe, permanent homes they deserve.

Dear Applicant:

This modifies our letter of the above date in which we stated that you would be treated as an organization that is not a private foundation until the expiration of your advance ruling period.

Your exempt status under section SO1(a) of the Internal Revenue Code as an organization described in section SO1(c)(3) is still in effect. Based on the information you submitted, we have determined that you are not a private foundation within the meaning of section SO9(a) of the Code because you are an organization of the type described in section SO9(a)(2).

Grantors and contributors may rely on this determination unless the Internal Revenue Service publishes notice to the contrary. However, if you lose your section 509(a)(2) status, a grantor or contributor may not rely on this determination if he or she was in part responsible for, or was aware of, the act or failure to act, or the substantial or material change on the part of the organization that resulted in your loss of such status, or if he or she acquired knowledge that the Internal Revenue Service had given notice that you would no longer be classified as a section 509(a)(2) organization.

If we have indicated in the heading of this letter that an addendum applies, the addendum enclosed is an integral part of this letter.

Because this letter could help resolve any questions about your private foundation status, please keep it in your permanent records.
