

Dear Public Service Director,

Transportation barriers are the #1 reason for missed cancer appointments.

The Road To Recovery program is at the very heart of the American Cancer Society's work of removing barriers to quality health care by providing transportation to cancer-related medical appointments. Many people need daily or weekly treatment, often over the course of several months. Family and friends may help, but they may not always have the time or resources to provide every ride, which can create a barrier to cancer treatment. The Road To Recovery program removes this barrier by providing free rides to treatment through trained volunteer drivers.

The Road to Recovery Program was paused in 2020 due to public health concerns during the pandemic. After relaunching the program in late 2021, the American Cancer Society was faced with a significant challenge of recruiting and reengaging volunteer drivers. Our current volunteer capacity is not meeting the demand for rides to critical cancer treatment appointments; about 55% of ride requests are unfulfilled.

We hope that you will help meet this urgent need for volunteer drivers in your market by airing the American Cancer Society's **Road To Recovery PSA (:30, :15)**. The PSA encourages individuals to give of their time and presence to drive a cancer patient to treatment, because even the best treatment won't work if a patient can't get there. The need is urgent and we hope you will share this message with your listeners by airing this PSA as soon and as often as possible.

We're responding to your request of Feb. 19, 2021, about the tax-exempt status of AMERICAN CANCER SOCIETY INC

We issued a determination letter in November 1942, granting this organization exemption from federal income tax under Internal Revenue Code Section 501(c)(03).

Our records show this organization is not a private foundation within the meaning of Internal Revenue Code (IRC) Section 509(a) because it's described in IRC Sections 509(a)(1) and 170(b)(1)(A)(vi).

Donors can deduct contributions to this organization as provided in Internal Revenue Code (IRC) Soction 170. Bequests, legacies, devises, transfers, or gifts to the organization or for its use are deductible for federal estate and gift tax purposes if they meet the requirements of IRC Sections 2055, 2106, and 2522.

If an organization fails to file a required annual return or notice for three consecutive years, its tax-exempt status is revoked by operation of law. This is stated in IRC Section 6033(j)(1). The revocation is effective on the filing due date of the third annual return or notice. For more information about filing requirements, you can visit our website at www.irs.gov/eo.
