

Dear Public Service Director.

As the country continues to face an ongoing mental health crisis, it has never been more important to provide people with the tools that they need to prioritize their mental well-being and ensure that their mental health is on par with their physical health. According to a recent national tracking poll conducted by the American Psychiatric Association Foundation (APAF) in collaboration with Morning Consult, nearly 40% of respondents indicated that they would be either very likely or somewhat likely to seek out resources about mental health conditions if they were struggling with their mental health. After viewing public service announcements (PSAs) from the APAF, 65% of respondents stated they would be inclined to seek help for their mental health condition. These findings from the APAF's polling underscore the value of offering mental health resources and information to those facing mental health challenges, as well as the public at large.

The APAF promotes mental health literacy and connects underserved communities to services and support. APAF also influences behaviors and attitudes toward mental wellness. We hope your station will join APAF in its mission to give individuals access to free mental health resources and to build a mentally-healthy nation by airing the latest PSAs that are part of the "Mental Health Care Works" campaign. The Mental Health Care Works initiative aims to empower individuals to take the first step in addressing their mental health by encouraging them to make the call for help. The campaign raises awareness around the signs and symptoms of mental health disorders and showcases the efficacy of seeking help. The goal is to show people that mental health care works and that it can work for them.

This public service campaign presents **new and updated testimonial-style PSAs** inspired by real people who are seeing (and feeling) the benefits of mental health care. The featured PSAs include "Robert" (:30, :15) which depicts how alcohol use disorder and addiction can take a toll on one's mental health and well-being. Also included are updated versions of the "Lizzie" (:30) and "Simone" (:30) PSAs. Each PSA highlights how these individuals overcame mental health conditions such as anxiety and depression thanks to mental health care. The "Robert" PSA has no end date for use. The additional PSAs are available for use through December 31, 2026.

The PSAs encourage audiences to learn more by visiting the campaign's informational website, mentalhealthcareworks.org, which has been updated with a number of important enhancements. This includes a direct, and simple call to action to help users understand their treatment options and take an active role in getting the mental health care they deserve. Additionally, the website features an expanded portfolio of relatable storytelling through personas struggling with addiction and OCD, along with a robust selection of condition-specific resources, providing users with even more ways to make the call.

We hope you can share these important messages with your listeners by airing these PSAs as soon and as often as possible. Thank you in advance for your support.



Dear Sir or Madam:

We're responding to your request dated December 15, 2021, about your tax-exempt status.

We issued you a determination letter in April 1982, recognizing you as tax-exempt under Internal Revenue Code (IRC) Section 501(c)(3).

We also show you're not a private foundation as defined under IRC Section 509(a) because you're described in IRC Section 509(a)(2).

Donors can deduct contributions they make to you as provided in IRC Section 170. You're also qualified to receive tax-deductible bequests, legacies, devises, transfers, or gifts under IRC Sections 2055, 2106, and 2522.

In the heading, we indicated whether you must file an annual information return. If you're required to file a return, you must file one of the following by the 15th day of the 5th month after the end of your annual accounting period.

- · Form 990, Return of Organization Exempt From Income Tax
- · Form 990-EZ, Short Form Return of Organization Exempt From Income Tax
- Form 990-N, Electronic Notice (e-Postcard) for Tax-Exempt Organizations Not Required to File Form 990 or Form 990EZ
- Form 990-PF, Return of Private Foundation or Section 4947(a)(1) Trust Treated as Private Foundation

According to IRC Section 6033(j), if you don't file a required annual information return or notice for 3 consecutive years, we'll revoke your tax-exempt status on the due date of the 3rd required return or notice.
