# NEW RADIO PSA TITLED "COFFEE DATE" FROM THE NATIONAL PEST MANAGEMENT ASSOCIATION HELPS PROTECT FAMILIES FROM HIDDEN HEALTH RISKS

We do everything we can to keep our kids healthy — nutritious meals, regular checkups, and plenty of love. But sometimes, what's triggering your child's asthma or allergies isn't something you can see. It's what's hidden.

This new PSA from the National Pest Management Association (NPMA) sheds light on the hidden health risks that pests pose inside homes. Pests like cockroaches and rodents can act as powerful asthma triggers. Rodents are associated with several health risks, spreading more than 35 diseases that can be transmitted to humans. Additionally, their droppings, urine and dander trigger asthma and allergy symptoms, especially in children. Cockroach control is important for health and safety reasons because cockroaches can trigger asthma and allergy attacks via their droppings, saliva, and shed skins which contain potent allergens that can exacerbate asthma symptoms. The campaign serves as a reminder that pests aren't just a nuisance — they're a health risk.

Your station can help educate listeners about these pest-related health threats by airing the new PSA titled "Coffee Date" (:30). The PSA highlights a heartfelt exchange between two mothers as they reflect on their children's health, recent asthma challenges, and the surprising role pests can play in worsening those conditions. The PSA encourages audiences to seek the facts needed to stay healthy and protected from pests by visiting <a href="PestWorld.org">PestWorld.org</a>, an informational website that offers further details and educational resources. This PSA has no end date for use. We ask that you please air this PSA as soon and as often as possible.

#### "Coffee Date" (:30)

MOM 1 O/C: How's Tommy doing now?

MOM 2 O/C: Much better.

**MOM 1 O/C**: That's terrifying.

**MOM 2 O/C**: Doctor said hidden triggers can make it worse. Things like dust, mold and even pests.

MOM 1 O/C: Pests?

<u>MOM 2 O/C</u>: Yeah. Droppings and allergens from cockroaches and rodents can seriously impact children with asthma or allergies.

MOM 1 O/C: I had no idea.

MOM 2 O/C: We're making sure our home stays pest free.

#### Dear Applicant:

In your letter dated 01/10/2024, you requested a reclassification of foundation status as a public charity.

Our records indicate you are tax exempt under IRC Section 501(c)(3). You're currently classified as a public charity described in IRC Sections 509(a)(3).

Based on the information you provided, we determined you meet the requirements for classification as a public charity described in IRC Sections (509)(a)(1) and 170(b)(1)(A)(vi) and updated our records.

Because your tax-exempt status wasn't under consideration, you continue to be classified as an organization exempt from federal income tax under IRC Section 501(c)(3).

This letter could help resolve questions on your foundation status. Keep it for your records.
