
## **ABOUT OCEANA**

Dear Public Service Director,

The oceans, covering more than 70% of our planet, play a critical role in regulating the climate, producing oxygen, and supporting life. Yet they face dire threats, from overfishing and habitat destruction to pollution and the killing of threatened species like turtles, whales, and sharks. These issues affect us all, no matter where we live, and protecting the oceans is vital for the health of the planet and the well-being of countless species, including our own.

Oceana, a 501(c)(3) nonprofit organization, is the largest international advocacy organization dedicated solely to ocean conservation. Oceana has been instrumental in protecting our planet's most valuable resource. By winning science-based policies in important coastal countries around the world, Oceana has achieved over 300 victories that help protect and restore the world's oceans. Within the last year, Oceana's campaigning helped create the largest marine protected area in the Gulf of Mexico, permanently protect U.S. coastlines from new offshore drilling, and safeguard whales and turtles from entanglements on the Pacific coast.

However, there is still more to do. North Atlantic right whales are in danger of extinction. Only about 370 North Atlantic right whales remain, and collisions with ships and entanglement in fishing gear are killing these magnificent animals every year. Meanwhile, plastic pollution is choking our oceans and harming marine life. Two garbage trucks worth of plastic enter the oceans every single minute.

We hope you will join us in our mission to protect the world's oceans by airing the PSAs titled "Turn the Tide – Join Oceana" (:30), "Save North Atlantic Right Whales – Join Oceana" (:30), "Stop Ocean Plastic Pollution – Give Today" (:60), and "End Plastic Pollution at the Source – Learn more" (:15).
