ABOUT THE TRANSPORTATION SECURITY ADMINISTRATION

The Transportation Security Administration (TSA) protects the nation's transportation systems to ensure freedom of movement for people and commerce.

Pursuant to the REAL ID Act and regulation, starting May 7, 2025, state-issued drivers licenses and identification cards must be REAL ID compliant for domestic travel. All travelers 18 years and older must present an acceptable form of ID at TSA airport security screening checkpoints.


TSA accepts many forms of identification in addition to state-issued REAL IDs and enhanced drivers licenses. To help travelers prepare for new air travel regulations, TSA has released a new public service campaign that encourages travelers to come to the airport with an acceptable form of identification and avoid potential travel delays.

TSA updates the list of acceptable IDs at the TSA security checkpoint, and recommends that travelers visit tsa.gov/id well in advance of their travel to review the full list.

Dear Public Service Director,

Starting May 7, 2025, all travelers aged 18 years and older will be required to present a REAL ID-compliant driver's license, identification card, or another acceptable form of ID at TSA airport security checkpoints.

To ensure travelers are aware of the requirements, the Transportation Security Administration (TSA) has launched a new public service campaign about the importance of traveling with an acceptable form of ID. The best way for passengers to avoid delays in travel is to come to the airport with an acceptable form of identification. TSA periodically updates its list of acceptable IDs, and travelers are encouraged to review the list prior to their travel dates to ensure compliance. Travelers who do not present an acceptable form of ID at the security checkpoint may experience delays in their travel as TSA attempts to verify their identity through alternate means.

We hope you can help share this important message with your audience by airing the PSAs titled **"Check Yourself" (:30)** and **"A Little Preparation" (:30)**. These PSAs aim to proactively spread awareness and reduce potential confusion and delays while helping travelers prepare for the new requirements. The PSAs, which have **no end date for use**, also encourage listeners to visit <u>tsa.gov/id</u> for more information about TSA acceptable forms of identification. Please share these important messages with your audience by airing these PSAs as soon and as often as possible.

"Check Yourself" (:30) ZTSA0023000

<u>MAN V/O</u>: The best words to hear at the TSA security checkpoint? You're good to go! So, check before you jet. Avoid delays at TSA security checkpoints by making sure you have an acceptable form of ID. That means a REAL ID, passport, or other acceptable forms of identification.

<u>NARRATOR V/O</u>: Visit TSA dot gov slash ID to check the full list of acceptable IDs. Avoid travel delays by checking ID requirements... and you're good to go!

"A Little Preparation" (:30) ZTSA0024000

MAN V/O: The best words to hear at the TSA security checkpoint? You're good to go! All it takes is a little preparation. Get to the airport early. Bring a carryon bag that fits in the overhead. And have an acceptable ID! Not all state-issued IDs will cut it. Check out TSA dot gov slash ID and see which TSA acceptable IDs make the grade, like a REAL ID, or passport.

<u>NARRATOR V/O</u>: Before you jet, do a little prep, and you're good to go! Check out TSA dot gov slash ID or the MyTSA app.
